We (the supplier) will comply with the site safety rules for driving on Lane Farm and exiting Green Waste parking bay, as this site is shared with a large stable yard and equestrian centre, therefore extra vigilance has to be made.

Park in appropriate Greenleaf parking bay.

Report to Greenleaf reception for relevant paperwork.

We (the supplier) confirm that we are only supplying Greenleaf Recycling with materials that include:

✓ *Green waste (Leaves, hedge/tree cuttings, branches, grass)*

Does NOT contain treated wood, metal/plastic (e.g. rubbish) or non-degradable materials.

Has NOT been treated with herbicides containing active ingredients Clopyralid and Picloram.

Does NOT contain Japanese Knotweed or Himalayan Balsam Weed.

* I confirm that I have fulfilled my duty to apply the waste hierarchy as required by Regulation 12 of the Waste (England and Wales) Regulations 2011

IF IN DOUBT - DISCUSS YOUR LOAD WITH US PRIOR TO DROP OFF

PPE/Hi-Vis MUST be worn when dropping off Green Waste/Collecting Products

PLEASE GIVE WAY TO PEDESTRIANS AND HORSES AT ALL TIMES

HORSES ARE NERVOUS ANIMALS AND EASILY FRIGHTENED. THIS CAN LEAD TO DANGEROUS SITUATIONS AND CAN ENDANGER LIFE, THEREFORE:

1. Proceed with caution, **DRIVE SLOWLY** and observe the speed limit at all times.
2. **MAX SPEED LIMIT 5 MPH.**
3. Please be aware of horses using the equestrian tracks and horses in the fields being frightened by your load.
4. **No clattering of chains or equipment allowed.**
5. **If horses spook (are afraid) or break free, PLEASE STOP.**

CAUTION – HORSE CROSSING POINT AND EQUESTRIAN TRACKS

The **CROSSING POINT** is situated 35m from the Greenleaf Parking Bay. **SIGNAGE** portrays 'Horses Crossing'.

Horses and pedestrians **CROSS THE ROAD** at this point to access the equestrian walkways. **Please SLOW DOWN and GIVE WAY.** (Wait until a horse has passed and give sufficient distance before you start up your engine.)
